OAC 252:100-5-2.1(a)(3) currently excludes permit exempt facilities from the requirement to submit an annual emission inventory to the Department.

The PBR would simplify the permitting process for facilities whose only obligation to obtain a permit is due to the presence of an emergency engine that is subject to a federal standard. The Department is proposing the rule as both permanent and emergency.
