Instructions-

Manifests must be printed on appropriate forms in accordance with OAC 252:515-21-5. A copy of the form is to be provided to the generator/landowner, tire hauler, and permitted used tire recycling facility. The original is to be forwarded to the Oklahoma Department of Environmental Quality (DEQ).

Section I. Section I is to be completed and signed by the generator.

Tire dealers must certify appropriate tire recycling fees have been remitted to the Oklahoma Tax Commission.

Section IA. Section IA is to be completed by the landowner if applicable. If the landowner is unavailable, or resides out of state, the DEQ may authorize another signatory prior to the removal of any tires.

Section II. Section II is to be completed and signed by the hauler.

Section IIA. Section IIA is to be completed and signed by the secondary hauler.

Section III. The permitted used tire recycling facility must return a copy of the completed manifest to the tire dealer within 30 days of receipt of the tires described on this manifest.

All parties must retain their copy of the manifest for a minimum of five years.

Permitted used tire recycling facilities seeking reimbursement from the Oklahoma Used Tire Recycling Indemnity Fund must submit the original copy of the manifest to DEQ along with any other forms required by the DEQ as part of the request for reimbursement.
