The operational budget request for State Fiscal Year (SFY) 2016 (beginning July 1, 2015) must be submitted to OMES by October 1st of this year. The law requires that all state agencies submit a five-year budget. The request for the coming year, SFY 2016, is the most critical.

In connection with these responsibilities, the Board has determined that it should conduct its annual performance review of the Executive Director.
