



INTRODUCTION

Under the federal Superfund program, the Oklahoma Department of Environmental Quality (DEQ) and the U.S. Environmental Protection Agency (EPA) are working to address contamination at the Imperial Refining Company Superfund site in Ardmore, Oklahoma. This is one in a series of site updates you will receive from DEQ and EPA as clean up efforts progress.

What's Happening Now?

REMEDIAL INVESTIGATION/FEASIBILITY STUDY

The DEQ is currently performing investigations to determine the type and extent of contamination at the Imperial site. The investigation will take approximately 2 years. DEQ's contractor, Weston Solutions, Inc., will collect soil, surface water, ground water, sediment and air samples. DEQ and EPA are working with Weston to complete the plans for the investigation. These plans will be finalized before sampling begins and will be available to review at the site information repository at the Ardmore Public Library as soon as they are published. The community can expect to see crews in protective gear onsite conducting sampling activities for about three months beginning in September 2005. The information gathered will be used to evaluate and understand risk related to the site and to identify the best way to clean up the site.





SITE HISTORY & BACKGROUND

The Imperial Refining Company (IRC) is an abandoned former crude oil refinery. It is located on either side of State Highway 142 in northeast Ardmore, Carter County, Oklahoma. IRC operated from 1917 to 1934. The refinery declared bankruptcy in 1934, ceased operations and dismantled all tanks and storage equipment by 1948. The property covers approximately 72 acres. There are numerous pits, piles, and water impoundments that are contaminated with metals and refining wastes. The site was evaluated and then proposed to the National Priorities List in May 2000 and listed in July 2000.



The refinery when it was operating in the early 1900s


Beginning in December 2000, the Environmental Protection Agency (EPA), Agency for Toxic Substances and Disease Registry (ATSDR), and Oklahoma Department of Environmental Quality (DEQ) began working together towards the Remedial Action and Feasibility Study (RI/FS).

They identify public health concerns and activities that might be needed and make recommendations to EPA, DEQ, or other state and local environmental and health agencies concerning actions to protect public health.

The remedial process is a three-stage progression that defines the nature and extent of the contamination (RI/FS), establishes the engineering plan to remedy the problems (Remedial Design), and constructs the selected remedy (Remedial Action) for Superfund sites.



ATSDR PUBLIC HEALTH ASSESSMENT

The Agency for Toxic Substances and Disease Registry (ATSDR) is a public health agency of the U.S. Department of Health and Human Services. Congress requires ATSDR to conduct a public health assessment on each site proposed for or listed on the National Priorities List (NPL), including the Imperial Refining site. Public health assessments report information about hazardous substances in the environment and evaluate whether exposure to those substances in the past, present or future could harm people in the area.


