## RULE IMPACT STATEMENT

**Subchapter 1. GENERAL PROVISIONS** 

252:100-1-2. [AMENDED] 252:100-1-3. [AMENDED]

- 1. **<u>DESCRIPTION:</u>** The Department is proposing to amend 252:100-1-2, Statutory definitions, to correct an incorrect statutory citation and update the latest statutory publication date. The Department is also proposing to amend 252:100-1-3, Definitions, to make a minor clarification to a definition, correct a truncated definition, add a definition for clarification, and alphabetically reorder a definition. The gist of this rulemaking is to correct a statutory citation and clarify and add definitions.
- 2. <u>CLASSES OF PERSONS AFFECTED:</u> The classes of persons affected by this rule proposal would be those who are regulated by Chapter 100.
- 3. <u>CLASSES OF PERSONS WHO WILL BEAR COSTS:</u> There are no classes of persons who will bear costs as there are no associated costs with this rule proposal.
- 4. <u>INFORMATION ON COST IMPACTS FROM PUBLIC/PRIVATE ENTITIES:</u> The Department has not received any information on cost impacts as of this date.
- 5. <u>CLASSES OF PERSONS BENEFITTED:</u> The classes of persons that would benefit from this proposed rule change are those that are regulated by Chapter 100. They would benefit from the corrected statutory citation and definitions.
- 6. **PROBABLE ECONOMIC IMPACT ON AFFECTED CLASSES OF PERSONS:** The Department expects no economic impact from this rule proposal since there are no costs associated with this proposed rule.
- 7. **PROBABLE ECONOMIC IMPACT ON POLITICAL SUBDIVISIONS:** The Department does not foresee any economic impact on political subdivisions due to this rule proposal.
- 8. **POTENTIAL ADVERSE EFFECT ON SMALL BUSINESS:** The Department anticipates no adverse effect on small business from this rule proposal.

- 15. EXPLANATION OF THE MEASURES THE DEQ TOOK TO MINIMIZE COMPLIANCE COSTS: There are no compliance costs associated with this rule proposal.
- 16. <u>DETERMINATION OF WHETHER THERE ARE LESS COSTLY OR NONREGULATORY OR LESS INTRUSIVE METHODS OF ACHIEVING THE PURPOSE OF THE PROPOSED RULE:</u> The Department has determined this method to be the least intrusive and least costly method to achieve the purpose of the proposed rule.
