This year, DEQ has launched a new online emissions inventory reporting tool called **SLEIS** (State and Local Emissions Inventory System), which replaces our previous system (Redbud). Oil & Gas Facility Categories – In order to improve the accuracy of data from area sources within the oil and gas sector submitted to EPA through the National Oil & Gas Emissions Inventory Tool, a new oil and gas facility category has been incorporated into the annual emissions inventory. Implementation of this category will begin with 2019 reporting in SLEIS. Please select the appropriate category for your facility. This selection is made on the Additional Information tab of the General Facility Information page. Once this selection is made, you will not need to make the selection in subsequent years, unless the facility changes category.

<u>DEQ Website Updates</u> – The new DEQ website was launched in July of 2019. The Emissions Inventory Section has a new Annual Operating Fee information page and an updated Oil & Gas Sector Emissions page that highlights the improvement in the emission estimates for the sector over the last decade. <u>SLEIS Data</u> – 2013 through 2018 historical emission inventory data has been loaded into SLEIS. Existing data required adjustments to conform to the new SLEIS data structure. Data brought forward may not pass SLEIS validation when entering and saving 2019 data, and will need to be corrected before the 2019 inventory can be submitted.

<u>2019 Permit by Rule (PBR) Reporting reminders</u> – Facilities that have registered under a PBR must submit an inventory for the calendar year in which they registered, and then get on the established PBR schedule, which requires inventory reporting of all PBR facilities for 2020 emissions year.

<u>Annual Operating Fees</u> – Invoices for 2020 Annual Operating Fees will be mailed July 1, 2020 and payments are due by July 31, 2020. The minor source fee is fixed at \$25.12 per ton of regulated air pollutant, and the Title V fee will be \$39.86 per ton. When calculating PBR annual operating fees, the last reported inventory emission amounts are used.
