DEQ staff will be proposing an update of the progress of the publication date of the federal rules from July 1, 2016, to July 1, 2018. The most significant changes include a rule that modifies the approved testing requirements for analysis and sampling under the Clean Water Act; a rule that sets February 6, 2020 as the applicability date of the new "Waters of the United States" definition; and EPA's effort to explain the two methods that a small MS4 system may obtain permit coverage.

The Department is proposing to amend OAC 252:653-1-5 to update the definitions of “Aquifer Storage and Recovery” and “Area of Hydrologic Effect” for consistency with the Oklahoma Water Resources Board; OAC 252:653-1-12 to provide permit application fees and annual operating fees for ASR; OAC 252:653-5-2 and OAC 252:653-7-6 to provide for notification requirements for ASR facilities; and OAC 252:653-7-7 to provide specific language requiring bench-scale and field-scale pilot testing for evaluating the compatibility of delivered water with the receiving aquifer for the purpose of ASR.
