### 1.0 INTRODUCTION

This section was prepared to provide the Certification Statement and a calculation of the permit renewal application fees.

### 2.0 APPLICATION CERTIFICATION

CPCC is including as Attachment N-1 a signed certification 40 CFR 270.11 (d), O.A.C. 252:205-3-2(k) that this permit renewal application and all attachments were prepared under the direction of an official of CPCC.

### 3.0 PERMIT RENEWAL APPLICATION FEE

Central Plains Cement Company (CPCC) uses fuel quality waste (FQW) in the kilns as alternative fuel in making Portland cement. The FQW is supplied to CPCC by Systech Environmental, Inc.
