

**OKLAHOMA DEPARTMENT OF ENVIRONMENTAL QUALITY
NOTICE - APPLICATION FILED**

Application filed. A solid waste Tier II application has been filed with the Department of Environmental Quality (DEQ).

Applicant: The applicant is the City of Tulsa, 175 East 2nd Street, Suite 15-041, Tulsa, Tulsa County, Oklahoma 74103.

Type of final permit or permit action being sought: The applicant seeks a permit for a new solid waste transfer station.

Facility location: The 440 Transfer Station is proposed to be located at 440 West 23rd Street, Tulsa, Tulsa County, Oklahoma 74107. See legal description below.*

Activities to be regulated if the application is approved: The proposed City of Tulsa 440 Transfer Station facility will be a non-hazardous solid waste transfer station located on an existing developed property currently owned by the City of Tulsa. The existing structures on-site will be used to support the transfer station operations with no additional structures planned. The transfer station will accept, sort, and transfer loads to the appropriate off-site location (landfill, recycler, mulch site, or waste to energy facility) to promote proper reuse, recycling, and off-site disposal of waste.

Statutes and Rules: The DEQ will review the application for compliance with the Environmental Quality Code, including the Solid Waste Management Act, Title 27A of Oklahoma Statutes, Section 2-10-101, *et seq.*, and the rules of the DEQ, Oklahoma Administrative Code, Title 252, Chapters 4 and 515.

Permitting procedures explained: Opportunities for public comment on this application will begin when notice is given that DEQ has completed its review of the application and has prepared either a draft permit or a draft denial. At that time, written comments may be sent and a public meeting for oral comments may be requested. The application may be reviewed at the locations listed below and may be revised by the applicant as the DEQ review progresses.

***Legal description of site:** A Tract of land lying in Government Lot 2, Section 14, Township 19 North, Range 12 East of the Indian Base and Meridian, according to the U. S. Survey thereof, said Tract being more particularly described as follows; Commencing at the East Quarter Section Corner (E/4) of said Section 14; thence S89°25'07"W along the South line of said Government Lot 2 a distance of 1223.70 feet to a point that is 100.00 feet from the Southwest Corner Section Corner of said Government Lot 2; thence on a line that is 100 feet from and parallel with the West line of said Government Lot 2, N01°12'55"W a distance of 470.00 feet to the Point of Beginning; thence N01°12'55"W a distance of 263.65 feet; thence N89°16'35"E a distance of 282.96 feet; thence N01°12'55"W a distance of 238.00 feet; thence on a line that is 90.00 feet from and parallel with the North line of said Government Lot 2, N89°16'35"E a distance of 114.00 feet; thence S03°30'00"E a distance of 75.50 feet; thence S46°13'00"E a distance of 52.50 feet; thence N64°10'09"E a distance of 12.17 feet; thence S46°20'50"E a distance of 103.50 feet; thence S43°53'40"W a distance of 92.50 feet; thence S22°13'20"E a distance of 38.00 feet; thence S01°12'55"E a distance of 135.00 feet; thence S41°38'30"W a distance of 37.00 feet; thence S60°17'00"W a distance of 56.50 feet; thence S02°41'00"W a distance of 26.00 feet; thence S88°30'00"W a distance of 393.00 feet to the Point of Beginning. Having an area of 158,110 Square Feet or 3.6297 Acres.
