Application filed. A solid waste Tier III permit modification application has been filed with the Department of Environmental Quality (DEQ). Interested persons now have the opportunity to request a meeting with DEQ to learn how and where they may participate in the permitting process.

Applicant: The applicant is: Waste Management of Oklahoma, Inc.

(Muskogee Community Recycling and Disposal Facility) 2801 S 54th Street W Muskogee, OK 74401

Type of final permit or permit action being sought: The applicant seeks to modify an existing Municipal Solid Waste Landfill permit to expand the permit boundary and waste boundaries.

Facility location: The Municipal Solid Waste Landfill is located at 2801 S 54th Street W, Muskogee, OK 74401. See legal description below.*

Activities to be regulated if the application is approved: The existing Municipal Solid Waste Landfill (DEQ Permit No. 3551020) currently receives residential and commercial waste, construction and demolition waste, non-hazardous "other" industrial waste, encapsulated asbestos waste, incinerator ash, vegetative waste, semi-solid waste, and sludges. The facility is seeking to expand the existing landfill permit boundary from approximately 80.5 acres to a proposed 316.8 acres. The waste disposal area will increase from approximately 60.9 acres to 126.4 acres. Over the life of the facility, the expected average daily volume of incoming waste is projected to be approximately 555 tons per day. These projections are based on current market conditions and may vary as market conditions change. The existing groundwater and landfill gas monitoring systems will also be expanded to monitor the expanded site. Surface water drainage improvements that will occur with the expansion consist of providing final cover erosion control structures, perimeter drainage channels, and stormwater ponds. The site is also designed to prevent stormwater run-on to the active portion of the landfill during a 24-hour, 25-year storm event. No variance requests are included in this modification.

Statutes and Rules: DEQ will review the application for compliance with the Environmental Quality Code, including the Solid Waste Management Act, Title 27A of Oklahoma Statutes, Section 2-10-101, *et seq.*, and the rules of the DEQ, Oklahoma Administrative Code (OAC), Title 252, Chapters 4 and 515.

Permitting procedures explained: On request, a representative of the DEQ will chair a meeting to explain the steps of the DEQ's permitting process to interested persons. At that meeting, there will be discussion explaining when oral and written public comments can be made on the proposal. Administrative hearing opportunities will also be discussed. To request this process meeting, send a written request to the DEQ representative named below within 30 days after the date this notice is published. Please note that this is not a meeting for protests, its purpose is to advise interested persons about participation in opportunities during the
