

**OKLAHOMA DEPARTMENT OF ENVIRONMENTAL QUALITY
NOTICE - DRAFT PERMIT MODIFICATION**

The Oklahoma Department of Environmental Quality (DEQ) received a Tier II application for a solid waste permit modification for a change in waste type and the addition of processing operations at Stealth Business Solutions, 29 W 7th St, Edmond, OK 73003, located in the NE ¼ of section 35, Township 14 North, Range 3 West, Oklahoma County, OK Block 001, Lots 21-26. The application was filed by Stealth Business Solutions on December 29, 2023.

The DEQ has tentatively found that the application meets the requirements of Title 27A of the Oklahoma Statutes, Section 2-1-101, *et seq.*, Section 2-10-101, *et seq.*, and rules of the DEQ, Oklahoma Administrative Code (OAC), Title 252, Chapters 4 and 515, and has prepared a draft permit modification for public review.

The draft permit modification and its conditions would allow the facility to accept and process (shred) no greater than 600 lbs / month of non-compostable cannabis industry waste including: food waste, glass, plastics and concentrates to be mixed with shredded, fermented hemp stalk and soil for disposal at a permitted landfill.

The application, draft permit modification, and related documents may be reviewed during normal business hours at the Central Records Office, Oklahoma Department of Environmental Quality, located on the 2nd floor of the DEQ building at 707 North Robinson, P.O. Persons wishing to comment on the draft permit modification should submit their comments in writing to DEQ at the above address or electronically to the DEQ at the website address above. Also, any person may request, in writing, a formal public meeting to present written or oral statements and data concerning the draft permit modification. A request for a public meeting must identify the nature of the issues to be raised in the meeting. If DEQ determines, based on the requests it receives, that there is a significant degree of public interest in the draft permit modification, it will schedule a public meeting and provide notice of the date, time and place.

Written comments and requests for a public meeting must be received by DEQ within 30 days after the date of this publication at the DEQ address given above.
