



## Statement of Interest for Brownfields Loan

The Oklahoma Department of Environmental Quality (DEQ) Brownfields Revolving Loan Fund (RLF) provides low interest, short-term financing for remediation of contaminated properties. The DEQ is soliciting statements of interest for properties that are already assessed and ready for cleanup. If eligible, loan terms will be negotiated. Please note that funds will be made available on a reimbursement basis for costs incurred. The loan statement of interest form is the first step in the RLF application process.

### **General Eligibility Information:**

- The applicant must be the owner (fee simple title) of the property that is the subject of the loan at the time the loan is awarded and must retain ownership throughout the period of performance of the loan.

DEQ's Finance Department determines financial viability and DEQ's RLF Project Manager works with the U.S. Environmental Protection Agency (EPA) to determine eligibility.

Please note that additional information may be requested from the applicant by DEQ before a final loan award decision is made.
