## Tar Creek Superfund Site Residential Yard Cleanup

**FREE Service for all Ottawa County Residents**

### Introduction

Since 1997, the Environmental Protection Agency (EPA) has worked to clean up residential properties, parks, and other publicly accessible areas impacted by mining waste associated with the Tar Creek Superfund Site. The Oklahoma Department of Environmental Quality (DEQ) will continue those efforts to make the local community cleaner and safer. DEQ strongly encourages you to have your property sampled for lead. ### Site History and Goals

The Tar Creek Superfund Site is part of the Tri-State Mining District, which includes northeastern Oklahoma, southeastern Kansas, and southwestern Missouri, where lead and zinc were mined from about 1900 to the 1970s. After the mining stopped, huge volumes of waste, including chat, were left on the ground. Due to the widespread practice of using chat as general fill material, lead contamination is common throughout Ottawa County and has contributed to human health and environmental concerns in the area. Children age six or younger are the most sensitive to lead and other heavy metals. Exposure to lead can cause adverse health effects and may impair a child's ability to learn. Our goal is to reduce the ingestion of lead-contaminated soil by people, especially children. This is accomplished by removing lead-contaminated soil and chat from your property. Your participation in this cleanup is strongly encouraged but entirely voluntary.

### How to Participate in DEQ's Residential Property Cleanup Program

- Call DEQ Hotline (1-800-522-0206) or the EPA Hotline (1-800-533-3508) to sign up.
- Meet with the DEQ Project Manager to discuss your property.
- DEQ will sample your property for lead or determine if your property has been previously sampled or cleaned.
- If contamination is not present, DEQ will provide a letter stating that your property is clean.
- If contamination is present, DEQ will cleanup of your property **FREE OF COST TO YOU**.

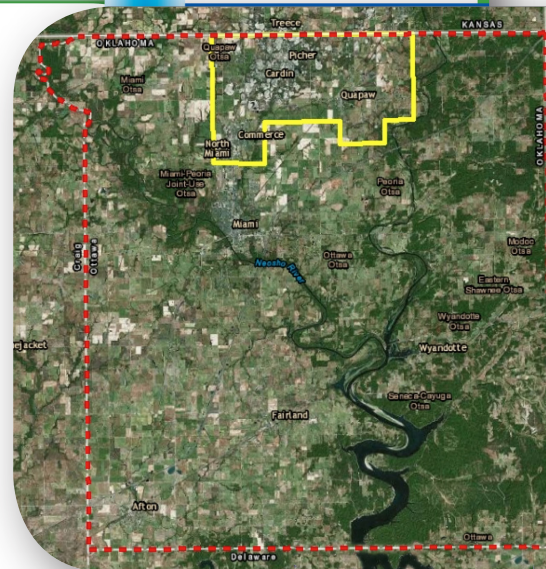
