**B. OAC 252:631 – "PUBLIC WATER SUPPLY OPERATION."**

DEQ staff will be proposing to: (1) amend the definition for "Public Water Supply (PWS) system; (2) update the rule concerning the date of the incorporation by reference of certain federal regulations from July 1, 2015 to January 1, 2017; (3) clarify the reporting requirements of 40 CFR 141; and (4) clarify that groundwater systems with certain advanced treatment processes must run a control test for "stability to calcium carbonate."

### **C. OAC 252:653 – "AQUIFER STORAGE AND RECOVERY."**

The Department is proposing to create a new Chapter, OAC 252:653 (Aquifer Storage and Recovery), to allow for a regulatory structure for an aquifer storage and recovery (ASR) program. The purpose of the Chapter is to enable DEQ to issue permits to those who wish to undertake an ASR project. The Chapter establishes a multi-phase permitting process and requirements for the construction and operation of an ASR project. The Chapter requires appropriate testing and modeling to ensure a project is feasible and that the aquifer is not harmed. In addition, the Chapter establishes the fees associated with ASR permitting and operations.
