RESULTS

Below are the results from the first and second rounds of testing of drinking water for lead that was conducted at Broken Bow Public Schools - Broken Bow High School. The initial sampling event occurred on April 8, 2022. The resampling event occurred on February 17, 2023.

In the initial sampling, thirty (30) outlets were tested resulting in a total of sixty (60) samples being sent to the lab.

- Forty-seven (47) samples had no detectable level of lead.
- Twelve (12) samples had a low detection of lead between 1.0 and 14.9 μ g/L.
- One (1) samples had a high detection of lead equal to or above 15.0 μ g/L.

In the resampling, four (4) outlets were tested resulting in a total of eight (8) samples being sent to the lab.

- Four (4) samples had no detectable level of lead.
- One (1) samples had a low detection of lead between 1.0 and 14.9 μ g/L.
- Three (3) samples had a high detection of lead equal to or above 15.0 μ g/L.
