

## Pre-Visit Checklist Capacity Development Assessment

## **Overview**

The Capacity Development Assessment serves as an exercise to help identify technical, managerial, and financial (TMF) capabilities of a water system that may significantly impact your ability to produce safe drinking water now and in the foreseeable future.

Prior to your scheduled meeting with DEQ, identify the following necessary personnel, and collect the following necessary documents, if available, for completing the exercise.
