**Facilities Exempted From Construction Permit Fees:**

Oklahoma Water Resources Board (OWRB) Emergency Grant projects authorized by Title 82 Oklahoma Statute, Section 1085.39 and Rural Economic Action Program (REAP) Grant Projects administrated by the OWRB are exempted from review fees for construction permits.

\* Note: This fee schedule was calculated based on the Consumer Price Index (CPI) for the most recent calendar year combined with the base rate published on July 1, 2011 for OAC 252:626 and OAC 252:656
