

RESULTS

Below are the results from the first round of testing of drinking water for lead that was conducted at Kids' Ranch Child Care LLC - Kids Ranch Childcare on September 21, 2021. Overall, fortyeight (48) outlets were tested resulting in a total of ninety-six (96) samples being sent to the lab.

- Ninety-one (91) samples had no detectable level of lead.
- Five (5) samples had a low detection of lead between 1.0 and 14.9 μ g/L.
- Zero (0) samples had a high detection of lead equal to or above 15.0 μ g/L.
